

Filing a Notice of Deposit of Unclaimed Funds

Effective January 16, 2015, trustees will no longer submit the Notice of Deposit of (Unclaimed) Funds (including Small Dividends) to the Clerk's office with a check. Instead, the event Notice of Deposit of Funds with USBC Clerk (Text Only) located in the Trustee/US Trustee category in the Bankruptcy Menu will be docketed by the trustee directly in the CM/ECF Document Filing System. Electronic payment will be made via the Automated Clearing House (ACH) module.

Step 1 After selecting the trustee as the party filer the user will be presented with the fee screen and will be prompted to enter the total amount of unclaimed funds/small dividends being deposited. If the total exceeds one thousand dollars, **DO NOT insert a comma.**

Enter the **TOTAL** Amount of Unclaimed Funds/Small Dividends Being Deposited With the Clerk of Court. Fee: \$

Step 2 In the next screen, the user will be prompted to select how many claimants are listed in the notice. In the example below, 4 has been selected. If the user has more than 7 to file in a single case, the user will have to use the event multiple times.

Step 4 After all claimant information has been entered, the user is presented with a summary of entered data.
